TERMS & CONDITIONS OF MEMBERSHIP

The applicant or the parent/guardian of the applicant under 18 years of age on behalf of the applicant (the Applicant), hereby

applies for seasonal membership to Marks Park Cricket Club (the Club) and agrees (should the application be accepted) to the following:

1. That the details specified on this form are accurate and correct and hereby give consent for me or my child/ward to participate in the activities of the Club, including games, training, tournaments, sporting tours and other events in which the Club will participate in.
2. The applicant shall remain a member of Marks Park Cricket Club and a seasonal member of Marks Park Sports Club until such time that the applicant informs the Club in writing to terminate their seasonal membership from the Club. The Club will issue a Letter of Release as required by the Central Gauteng Lions only after all payments and commitments from the applicant or the parent/guardian of the applicant under 18 years of age on behalf of the applicant are settled in full or agreed with by the Club Executive.
3. That the applicant will abide by the rules, Constitution, Policies and Codes of Conduct of Marks Park Cricket Club, Marks Park Sports Club, the Central Gauteng Lions and any other tournament or events rules that the Club participates in.
4. The applicant will behave in a sporting manner that will enhance the overall reputation of the Club and the applicant's growth in cricket.
5. The applicant agrees that coaching, team selection and batting and bowling orders and field placements will be left to the coaches, administrators and/or selectors who will always act in the best interest of the Club first.
6. That the applicant will pay the fees and/or agree in writing with the Club Treasurer or Club Administrators the terms on which to pay the fees specified for membership to the Club before end November each season.
7. The applicant acknowledges that he/she is aware that the registration fees for new applicants and one third of the subscription fees for new and existing applicants are non-refundable fees incurred on acceptance of the applicant as a member and will not be refunded to the applicant in the event of the applicant terminating his/her membership before the end of the season.
8. The applicant acknowledges that failure to pay the fees specified for the season and failure to abide by the rules, policies, codes of conduct of Marks Park Cricket Club, Marks Park Sports Club and the Central Gauteng Lions may result in the termination of membership of the Club, in which event the applicant will remain liable for payment of all fees due at the date of termination.
9. The applicant acknowledges that all communications for games will be sent via Teamer.net and that the applicant will ensure that they respond to communications sent from Teamer.net.
10. The applicant agrees to respond timely and by the due date to requests sent on Teamer.net communications for games, training and other events or any other form of communication sent from the Club.
11. The applicant agrees that transport and transport arrangements to and from training, games and events will be their responsibility and not that of the Club coaches or administrators.
12. The applicant agrees and acknowledges that it is the applicant's responsibility to contact the Club Administrators directly if the applicant is not receiving communications through Teamer.net, and/or if any of the applicant's contact details indicated under Communication Preferences change.
13. The applicant declares that he/she is not a member of any other Central Gauteng Lions Affiliated Club and if so, is in possession of a letter of release from the previous Club.
14. The applicant indemnifies Marks Park Cricket Club and Marks Park Sports Club, their management, administrators, coaches, coordinators, staff, affiliates, sponsors and members for any loss of property and/or injuries sustained whilst attending coaching sessions, playing in games, participating in activities before, during and after games, training or events, including transportation to and from games, training and events, these being arranged for and on behalf of the Club.
15. The applicant agrees to make good all damage to and/or loss of property including buildings, facilities, furniture or equipment, which may occur as a result of wilful and malicious intent by the applicant.
16. The applicant authorises Marks Park Cricket Club, Marks Park Sports Club and the Central Gauteng Lions to use the applicant's playing records and/or photographs and videos in publications, electronic, social and other media to promote the Club.
